If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are

validated online through Udvam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. ## Additional terms & conditions

- 1) **SCOPE OF SUPPLY:** Supply of Stable Bleaching Powder confirmed to IS-1065/largest, Grade-1 ISI marked at our Jaduguda Mill Site, Unloading from truck and stacking at our stores /site stores /godo wn. Jaduguda Mill is 25 KM away from Tatanagar Railway station. In case of emergency, truck loade d consignment material shall be diverted to unload at Turamdih Plant which is 06 KM from Tatanag ar Railway Station without any financial implication.
- 2) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will liable to be rejec ted. Conditional offer will also liable to be rejected.
- 3) **Delivery Schedule:** As mentioned in bid. However delivery quantity in each lot may vary by 10%.
- 4) Unloading of material at site is under the scope of the work of the supplier.
- 5) Material should be in 25 Kg of laminated HDPE bags having two inner liners and tied at the mouth.
- 6) Test certificate should be furnished along with each consignment. Sampling of each consignment shall be done at our end with grab sampling method and shall be analyzed in our lab. Our analysis shall be treated as final and binding to both.
- 7) **Pro Rata Penalty:-** Bleaching Powder supplied should be having minimum 34% chlorine. For supply having less than 34 % chlorine content, Pro Rata deduction shall be effected on the basis of landed value of particular invoice as under:-

- a) If the Chlorine content is below 34% but up to 30% Pro Rata deduction will be effected on the basis of landed value of particular invoice.
- b) If the chlorine content below 30% material shall be rejected.
- c) In case of (a) you will not be allowed to take back of material for replacement.

**For Example:** If pro rata value comes 33.49%, it will be rounded off as 33% & if it comes 33.50% than it will be rounded off 34%.

- 8) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related pa rties in which there seems to be collusion are liable to be rejected. Parties are considered to be rela ted if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
