- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications.  - a. **CONCILIATION**: Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their au thorized representatives, shall be resolved through conciliation.
 - b. **MEDIATION**: Any disputes or differences, which are not settled amicably through conciliat ion, then either of the parties, may approach for mediation to settle under mediation Act, 2 023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended fro m time to time.
 - c. **AMRCD**: Any disputes or differences between the parties are not settled amicably with co nciliation and/or Mediation, then such disputes or differences shall be resolved through Ad ministrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
 - d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the part ies may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provi ded the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with refer ence to the value of the dispute and not the value of the contract which may be much high er. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
 - e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be re solved in civil court of law at Jharkhand only.
- 7) Material test Certificate from government authorized laboratory supplied item must be submitte d along with supply.
- 8) Pre- dispatch inspection certificate must be submitted along with supply of materiel.

- 9) However Final inspection shall be done at our site.
- 10) Final inspection shell be done at our site.
- 11) Nut must be fitted with each bolt.
- 12) Each bolt must be made of integral bar machined and threaded. No welding / thread joint is allow ed anywhere in bolt.
