1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Analysis report of UCIL lab will be final and binding. Pro rata deduction will be made for material bel ow the specified grade as under;

- a) 99.5% to 97%: no deduction shall be applicable.
- b) Below 97% up to 96%: single pro-rata deduction on the cost of material.
- c) Below 96%: Rejection of material.

d) In Case of stock out situation, material below 96% will be accepted by UCIL withdouble pro rata d eduction on cost of material. However below 95% material will berejected.

8) Sampling collection and analysis.

a) Unloading of Caustic soda flakes bags will be done by the supplier at Jaduguda mill as

instructed by Section In-charge(Mill).

- c) Party may allocation their representative at the time of unloading and sampling.
- d) During unloading one in every twenty bags must be segregated randomly forcollection. The sa mple will be collected by using hand showel/scoop from the segregated sample bags. The total quantity of sample shall be 2 kg in the double layer polythene bags.
- e) After sample collection in the polythene bag is properly tied at the neck to prevent its contact with moisture. The tagged sample shall be provided with the party name, Invoice no, truck no a nd the sample send to laboratory for analysis.
- f) Re-sampling of material will not be allowed in any case.
- g) Analysis report of UCIL shall be treated as final & binding for the sample collected 0.5 & above % of NaOH will be rounded off to next integer.

For Example:- If analysis value comes to 94.49%, it will be rounded of to 94% & if it comes 94.50% than it will be rounded of 95%.

- h) Since NaOH hygroscopic material, re-analysis of material will not be allowable.
- 9) **Deviation of Order Quantity:**Up to 10% variations in the execution of purchase order of the total order value for sanctioned order value is allowed without issue of amendment / revision in the purc hase order.
- 10) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related partie s in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.

- c. **AMRCD**: Any disputes or differences between the parties are not settled amicably with co nciliation and/or Mediation, then such disputes or differences shall be resolved through Ad ministrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differe nces relating to interpretation and application of the provisions of commercial contract(s) b etween Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between C PSE(s) and Government Department(s) / Organization(s) shall be taken by either party for i ts resolution through AMRCD.

- d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the part ies may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provi ded the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with refer ence to the value of the dispute and not the value of the contract which may be much high er. In all other cases, arbitration shall not be a method of dispute resolution arising out of t his contract.
- e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be re solved in civil court of law at Jharkhand only.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer

is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
