### **Pre-Qualification Criteria:**

#### **A. Experience Criteria:**

The bidder should have orders for similar works during the last Seven years ending last day of the month previous to the one in which tender is floated, to any company as below:

- a. One similar work order/ Purchase order costing not less than the amount equal to **80 %** of the estimated cost (Approximately **Rs. 14,58,480/-**). (OR)

- b. Two similar work orders/ Purchase orders each costing not less than the amount equal to **50% of the estimated cost (Approximately Rs. 9,11,550/-) ... (OR)**
- c. Three similar work orders/ Purchase orders each costing not less than the amount equal to **40 % of the estimated cost (Approximately Rs. 7,29,240/-) ...**

**Note:** Similar Work order means "Supply and commissioning of Agitators / Thickeners of any capacity either in Lab scale (or) Industrial scale".

(The work orders to be submitted may not contain only agitators / Thickeners, any works other than these equipments can be associated in the work orders/Purchase orders submitted, however the Agitators / Thickeners should be a part of the order.)

## **B. Financial Criteria**

The average annual financial turnover of the Bidder during last (3) three consecutive financial years ending 31<sup>st</sup> March 2023 shall not be less than **Rs.05.47** Lakhs. Bidder shall submit signed copy of Audited Annual Financial Reports for last 3 (three) consecutive financial years ending 31st March 2023 (Balance Sheet and Profit & Loss Account). Chartered Accountant signed/authorized Balance Sheet and Profit & Loss statements to be furnished by Bidders for fulfilling financial eligibility and they should clearly indicate the details of the Membership No. & Firm No. of the Chartered Accountant and UDIN number. In case Bidder is not able to submit the above, for genuine reasons to be specified in writing, Chartered Accountant's Certificate, in original, may be submitted to substantiate the financial eligibility. The Chartered Accountant's Certificate should clearly indicate the details of the Membership No. & Firm No. of the Chartered Accountant and the UDIN. Also

- a) The average shall be compared with the minimum requirement to ascertain the eligibility status of the bidder.
- b) If any bidder does not submit the Turnover value for any of the 3 years, the bidder will not disqualify and instead shall consider all 3 years for computing the average assuming a value of "zero" for the year for which no information has been furnished by the bidder.
