Kharkai pump House site may be inspected by bidders prior to submission of offer.

Terms and Conditions:

- Security deposit: Total amount of the security deposit will be 10% of the total value of awarded work. 50% of this S. D. amount shall be deposited at the time of agreement and balance 50% will be deducted from your bills.
- 2. <u>Rate:</u> The Unit rate of items mentioned in Schedule-C (Schedule of items) shall be inclusive of P.F., Bonus, ESI, P.F. Admin Charge, EDLI and GST.
- 3. <u>Reimbursible Payments:</u> The following payments plus Service Charge @3.85% and G.S.T. shall be reimbursed extra over and above the work order value as per extent defined against each.
 - The escalation in minimum wages as per Govt. Circular in vogue including PF, Bonus, ESI and EDLI will be paid extra for the period of contract subject to submission of proper and valid documentary proof by the contractor showing payment of escalated wages, PF, Bonus, ESI and EDLI to his employees to the Engineer-In-Charge or his representative. For the reimbursement of escalation in minimum wages the due date for submission of offer as mentioned in this Enquiry shall be considered as base date in this work.

- ii) Extra Wages to the engaged operators for Paid Holidays during the period of the Contract as observed by the Corporation (i.e. 1 National Holidays + 1 Paid Holidays) i.e. Maximum 2 paid holidays.
- iii) Cost for Supplying Tools and Tackles by the Contractor to his engaged operators as per Schedule-B @ Rs.509.59/- per operator on submission of valid documentary evidence only. In case, no tools & tackles are being supplied by the Contractor to his engaged operators and the same are supplied by UCIL, then an equal amount as per the rate defined above shall be deducted from the monthly running account bills.
- iv) Cost for Supplying PPE/Safety Appliances by the Contractor to his engaged operators as per Schedule-B @Rs.636.99/- per operator on submission of valid documentary evidence only. In case, no PPE/safety appliances are being supplied by the Contractor to his engaged operators and the same are supplied by UCIL, then an equal amount as per the rate defined above shall be deducted from the monthly running account bills.
- v) Cost of Insurance Policy to cover liabilities under Employee Compensation Act 1923 for all operators engaged by the Contractor for the whole period of the contract to indemnify UCIL on submission of valid documentary evidence. The Contractor shall provide a copy of the same to the Engineer-In-Charge or his representative as and when demanded by UCIL.
- 4. <u>Penalty Clause:</u> The contractor shall arrange for deployment of Min. 03 (Three) Nos. of D.G. Set operators on each working day i.e. (1 No. D.G. operator in each of the A, B and C-shifts or as per direction of Engineer-In-charge or his representative). However, in case of absenteeism of D.G. Set operators or deployment of less than 03 (Three) Nos. of D.G. Set operators per day, Penalty shall be imposed as per following Penalty rate:

For skilled (D.G. Set Operator): Rs.300/head/day

The calculated amount as per deployment of less D.G. Set operator than specified above shall be deducted from your R.A. Bills as per Penalty Rate mentioned above.

- 5. <u>Taxes:</u> Taxes shall be applicable as per prevailing rules.
- 6. <u>Completion period:</u> 93 days (approx.) i.e. 3 months. Completion period shall be counted from the date of start of work.
- 7. <u>Scope of work:</u> Supply of skilled operators for operating of DG set installed at Kharkai river pump house for 3 months.
- 8. The operators shall have the experience of operating DG set of rating 500 KVA or above.

- 9. The operators shall start and/or stop the DG set during 'A' shift, 'B' shift and 'C' shift as per requirement of pumping operation for Kharkai Pump house and also whenever need arises or as per direction of Engineer-in-Charge or his representative.
- 10. The operators shall maintain Log Book of DG set daily. The operators shall also maintain the log sheet of DG Set operation and maintenance and present the same to UCIL as and when demanded.
- 11. The operators shall be able to rectify small problems of the DG set as and when required. The operators shall also attend the electrical maintenance jobs related to other starter panels, switches etc. required for pumping operation. The operators shall also take care of the 11 KV overhead line to Kharkai Pump house and attend minor breakdowns of the same. The operators shall report to the Engineer's representative at the start and end of their respective shifts. They shall also immediately report any issue to the Engineer-In-Charge or his representative.
- 12. Necessary information about the financial and technical resources, organization and experience to undertake the jobs for such system/equipment shall be supplied by the Contractor as an evidence of his capability for satisfaction of the owner.
- 13. The job site is situated at Kharkai river site.
- 14. Turamdih is situated in district Singhbhum-East of Jharkhand, at a distance of about 6 km from Tata Nagar Railway station, S.E. Railway.
- 15. Payment terms: Two monthly R.A. Bills and one final bill shall be allowed.
- 16. Safety precautions and discipline shall be maintained during execution of work, failing which, the work order is liable to be cancelled.
- 17. The operators shall receive diesel oil filled drums which shall be sent to the site as per requirement regularly by UCIL. They shall also fill the diesel tank of the DG set as and when required. The job also includes unloading of diesel filled drums from vehicle and loading of empty drums on vehicle.
- 18. The Contractor shall be fully and finally responsible for proper job, safe and satisfactory operation of DG set.
- 19. The work shall be executed in accordance with the directions, instructions, and specifications, which shall be given to the contractor by the UCIL Engineer-in-Charge or his representative from time to time.
- 20. Safety Measures: All safety rules & codes as applicable shall have to be followed by the D.G. Set operators.
- 21. The contractor shall pay to labour employed by him wages not less than fair wages as defined in the Contract Labour (Regulation and Abolition) Act 1970 and rules made there under.

- 22. The Contractor shall at all times Indemnify the Corporation against all claims, damages, or compensation under the provisions of payment of wages Act 1936, Minimum Wages Act 1948, Employer's Liability act 1938, The workmen's Compensation Act 1923, Industrial Disputes Act 1947, and Maternity Benefit Act 1961 or any modifications thereof or any other law relating thereto and rules made there under from time to time or as consequence of any accident or injury to any workmen or other persons in or about the works, whether in the employment of the Contractor or not, (save and except where such accident or injury has resulted from any act of the Corporation, it's agents or servants) and against all cost, charges and expenses of any suit action or proceedings arising out of such accident or injury and against all sum or sums which may with the consent of the Contractor be paid to compromise or compound any such claim, without limiting his obligations and liabilities as above provided. The Contractor shall insure against all claims, damages or compensation payable under the Workmen's Compensation Act 1923 or any modification thereof or any other Law relating thereto.
- 23. The Contractor shall execute an additional Insurance to indemnify the corporation as mentioned above at Clause 20 at all times during the period of the contract and the till the end of the defect liability period thereafter. The copy of such insurance policy shall be made available to the corporation whenever demanded.
- 24. The contractor shall comply with the provisions of the payment of Wages Act 1936, Minimum Wages Act 1946, Employers Liability Act 1938, Workman's Compensation Act 1923, Industrial Disputes Act 1947, Maternity Benefit Act 1961 and of any modifications thereof or any other Law relating thereof and rules made there under time to time. The contractor shall arrange to provide P.F. and Bonus to his employees engaged for this job as per existing rate.
- 25. The contractor shall supply skilled DG operators having min. 05 years experience in operating D.G. Set. The D.G. Set operators shall be deputed such that I (One) No. operator is deputed every day in each of A, B and C Shifts. The contractor shall also supply DG Operators on Sundays and National Holidays as mentioned above. Total 4 (Four) Nos. of operators shall be supplied including reliever as per above. All the operators shall be provided mandatory weekly off every week as per standard rules. The Contractor shall maintain the Muster Roll for 4 Nos. of DG Set Operators including reliever for this work.
- 26. The Operators shall also be required to start and/or stop D.G. Set (if installed at site) of 3 phase, 15 KVA, 415 Volts AC, 50 Hz as and when required and as per the instruction of UCIL engineer in charge or his representative. (If 15 KVA DG set is installed)
- 27. G.S.T. shall be paid extra as per prevailing rate only on submission of valid documentary proof to the corporation for submission of G.S.T by the bidder.
- 28. Copies of valid workmen insurance, copies of I.D. proof (Voter I.D. etc.), 1 no. passport photo and copies of Gate Pass (issued by UCIL) for persons deployed for this job shall have to be submitted by the contractor on their expenses to the Engineer-in-charge or his representative before starting of the job.

- 29. Medical fitness certificates duly certified for persons deployed for this job shall have to be submitted by the contractor on their expenses to the Engineer in charge before starting of the job.
