2. Minimum average turnover of **Rs. 1.44 Lakh** i.e.30 % of the estimated value of the work for last 3(three) financial years and submission of duly audited copy of Profit & Loss account and Balance sheet of financial years 2021-22, 2022-2023 & 2023-24 by Chartered Accountant.

3. The Bidder shall submit registration copies of PAN, GST, MSME/NSIC, PF, ESIC and Income Tax Return Statement.

Similar Works means- **Deployment of Manpower for civil work / Sanitation Work**with Govt. / PSU / Public Limited Organization / Private Limited Organization."The contractor will have to submit copy of the work order as well as the completion certificate from the concern department in support of their experience/ credential.

5. GEOGRAPHIC PRESENCE:

Office registration certificate: Registered office or at least one of the registered branch office of the bidder shall be located and registered within the geographical limits of Dist - **East Singhbhum, Jharkhand** state where the services needs to be provided. 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
