- 1. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

PRE-QUALIFICATION CRITERIA (PQC)/ ELIGIBILITY CRITERIA

1. FINANCIAL STANDING:

Minimum Average Annual financial turnover during the last 3(Three) consecutive financial years, e nding 31/03/2024 shall be at least 30% i.e. Rs. 14.40 Lakhs of the estimated value as per actual pr ofit and loss statement and Balance sheet for the financial year.

2. PAST PERFORMANCE AND PRIECT / PAST EXPERIENCE etc. CRITERIA:

The bidder shall have to produce documentary evidence to prove their job experience in similar works during last 7(seven) years ending on last day of month previous to the one in which a pplications are invited. Documentary evidence in the form of **work order and completion Certificate copies** specifying the work and amount of contract should be uploaded:

a) One (1) similar completed works costing not less than the amount equal to 80% i.e. Rs.38.40 Lakhs of the estimated cost.

Or

b) Two (2) similar completed works costing not less than the amount equal to 50% i.e. Rs. 24.00 Lakh s of the estimated cost

Or

- c) Three (3) similar completed works costing not less than the amount equal to 40% i.e., Rs. 19.20 La khs of the estimated cost
- 3. The Bidder shall furnish a copy of GST, MSME/NSIC, PF and ESIC Registration.
 - Note: 1. similar works means "Experience in execution of "Transportation work of Minerals/ Tailings/ Sand/ Aggregates/ Fly Ash/ Other Minerals"
 - 2. Offers of the tenderer will be rejected if they fail to fulfill the above criteria.
- 4. RELAXATION OF CONDITIONS OF PRIOR TURNOVER AND PRIOR EXPERIENCE:
 - i. EMD exemption only to relevant MSME/MSE.
 - ii. Turnover exemption only for relevant Startups as per government guidelines
 - iii. Tender Cost exemption to relevant MSME/MSE
 - 5. **GEOGRAPHIC PRESENCE:**

The bidder participating in the bid must have the Head Office or a Branch Office in the East Singhb hum district of Jharkhand. Any document issued by Govt. of India or Govt. Authority of Jharkhand s hall be considered for address proof like UDYAM, GSTIN, Trade License issued by Govt. Authority of Jharkhand etc.

- i. Trade License issued by the local authority in the name of the Firm or
- ii. Landline phone number in the name of the Firm or
- iii. Electricity bill for last one year in the name of the Firm or
- iv. GSTIN registration or
- v. Udyam/MSME/Udyog Aadhaar Certificate.

Note: - 1. Mere submission of Rent Agreement shall not be considered for Office Address proof.

DETAILED SCOPE OF WORK

The scope of this tender will be generally as per specification schedule of quantities and general / special conditions of contract and as directed by Engineer in charge, on behalf of Corporation. However, the scope of work covered complete in all respect under this contract are as follows:

- 1. Loading of Uranium ore by mechanical means like wheel Loader from UCIL, Bagjata Mines and transportation of the same up to Mill of UCIL, Jaduguda in covered and well maintained Tippers/Dumper and dumping the same at ground hopper of UCIL Mill, Jaduguda including weighment at Jaduguda weigh bridge as per directions of Engin eer-in-charge.
- 2. Loading of Mill Tailing by mechanical means such as wheel loader/JCB Loader from UCIL Jaduguda tailing padd ock, weighment of tailings to be done at Jaduguda weighbridge and transportation of the same up to UCIL, Bagjat a Stowing yard in covered and well maintained Tippers/Dumpers, inclusive of all handling, tools etc. complete, as per directions of Engineer-in-charge.
- 3. Bagjata Mines is located 32 km East of Jaduguda Mines and 11 km East of Mosaboni Mines in the Singhbhum E ast district of Jharkhand State.
- 5. For quality check of ROM, all Tippers carrying ore have to pass through the BOA (Bulk Ore Analyzer)/ARCH Roo m before it is being dispatched to Jaduguda.
- 6. Schedule of work mentioned in BOQ to be carried out as per direction of Engineer-in-charge.
- 7. The heavy vehicles required for the work on hire basis should not be manufactured earlier than the year 2016.
- 8. Spillage etc during transportation of ore and tailing

While transporting, all loaded dumpers/Hyva etc must be covered with Tarpaulin as per following specification.

- (a)Tarpaulin made of canvas/high-density polyethine cloth stitched and having eyelets fitted on all borders. The size of the tarpaulin shall be larger than the dump box so as to cover the top of the dump box completely.
- (b) The tarpaulin is to be fixed on all side hooks of the dumper in such a way that at least it will be 200mm below from the rim of the dump box.
- © Tarpaulin must be changed as and when insisted by the Engineer in charge, to avoid the dust and spillage in the public surrounding area/villages/on road.

9. Dumping of ore and tailing outside company area

If dumping of ore or tailing becomes unavoidable due to repair and maintenance or any other reasons like overturning or any other accidental causes the Tenderer shall clear the dumped ore or tailing within 48 hours of such in cident and failing to above, the UCIL shall take steps to clear the ore or tailing and the cost incurred shall be deducted from the running bill of the Tenderer. The cost involve to clear the ore or tailing shall be intimated to the Tenderer within 48 hours before carrying out the work and if Tenderer does not reply immediately after getting the intimation it will be deemed that Tenderer has no objection to the estimated cost.

Note:-Contractors are advised to see the area get acquainted with the actual features of the land w here work is to be executed and get other related information before quoting their rates for carryin g out the work successfully.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
