1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

Prequalification criteria:

The Tenderer who wish to participate in the Tender shall fulfill the following Qualifying Criteria.

i). Experience of having successfully completed the jobs during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:-

- a. One single similar completed job costing not less than **Rs. 11.44 lakhs** or
- b. Two similar completed jobs costing not less than **Rs.7.15 lakhs** each or
- c. Three similar completed jobs costing not less than **Rs. 5.72 lakhs** each.

Similar works means "**having experience of execution/performing of contracts of works related to supply of manpower i.e. supply of technical teaching faculty/instructors for any Degree/Diploma/ITI institute/College i.e. Degree holder/Diploma holder/NCVT (ITI) as per norms of faculty required for the trades as per DGT norms**".

ii). The Tenderer's average annual turnover for the work during last 07 financial years, ending 31st March of the previous financial year, should be at least **Rs. 4.29 lakhs** in balance sheet & profit & loss account of each year must be submitted by the tenderer.

Documentary evidence in the form of Certificates from clients/Work Order copies specifying the work and the amount of contract should be submitted.

iii.) **Geographical Presence:** Bidder should have registered office within the limits of East Singhbhum/West Singhbhum/Seraikela Kharsawan Districts in the State of Jharkhand in order to have better communication and feedback.

Documentary evidence for the above must be submitted in the form of Municipality Trade License or other such documents as per the following which satisfies as a proof of having the office establishment:

- a) Trade License issued by the Local Authority in the name of the Firm OR

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
