Pre-Qualification Criterion (PQC):

The bidder should have experience of having successfully completed similar works during last 7 years last day of month previous to the one in which applications are invited should be either of the following:

- a. One similar work costing not less than Rs 35.60 Lakh
- b. Two similar works each costing not less than Rs 22.25 Lakh.
- c. Three similar works each costing not less than Rs 17.80 Lakh.

Similar work means work for Manpower supply for Mechanical works/ Civil works / Electrical works / Mining works.

2. GEOGRAPHIC PRESENCE:
