Scope of work:

Maintenance of all units/equipment at Bagjata mine will give longer service life and will avoid loss of time and expensive repairs. Maintenance schedule given in the manual is based on normal working conditions and it shall be followed predominantly.

Time schedule may change depending upon the working condition e.g. dusty or humid atmosphere.

Damage may occur sometimes before our expectations. To avoid loss of time in getting new spare parts, it is necessary that essential spare parts are procured in time and kept in stock.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
